The Board of Directors shall not enter into any contract on behalf of the Association in excess of \$10,000.00 before public advertising and posting for sealed bids from at least three (3) reputable firms or businesses regularly engaged in performing the work or providing the goods and material which would be the subject of the contract. The contract shall be awarded by the Board of Directors which shall not be required to accept the lowest bid but shall consider the amounts bid along with other factors they determine to be relevant. In the event that at least three (3) bids cannot be obtained, then, and in that event only, upon approval of three fourths (3/4) vote of the Directors then in office, said bid requirements may be waived or modified as the Board of Directors shall determine.

Change To:

The Board of Directors shall not enter into any contract on behalf of the Association in excess of \$15,000.00 before public advertising and posting for sealed bids from at least three (3) reputable firms or businesses regularly engaged in performing the work or providing the goods and material which would be the subject of the contract, "with the exception of legal services, accounting services and lake management services." The contract shall be awarded by the Board of Directors which shall not be required to accept the lowest bid but shall consider the amounts bid along with other factors they determine to be relevant. In the event that at least three (3) bids cannot be obtained, then, and in that event only, upon approval of three fourths (3/4) vote of the Directors then in office, said bid requirements may be waived or modified as the Board of Directors shall determine.
