### **Section 2.10 - Voting Rights of Members**

(B) Voting by Absentee Ballot. Every Official Absentee Ballot shall be executed by the member and filed with the WALPOA Office. To be filed and considered valid, an Official Absentee Ballot(s) shall be delivered, in person or by a deeded member of that property or via US Mail to the WALPOA Office. An Official Absentee Ballot will be delivered no later than 4 p.m. EST of the Wednesday before the meeting, at which the vote will be cast. Official Absentee Ballots may not be counted as constituting an amendment to the bylaws pursuant to section 8.2 of the bylaws.

WALPOA Treasurer, Bill Fells, has been pouring over the community budget challenge of building our new clubhouse as is currently planned. Based upon a liberal estimated total cost of \$4 million dollars, the community will need to meet lender requirements by providing a downpayment of 20% of the mortgage which is \$800,000.

Our current Clubhouse Capital Project balance as of 03/31/2025 is \$523,120. Pending expenses that will be deducted from this balance include demolition and Township fees totaling \$112,510, reducing the Project's available balance to \$410,610. This balance leaves us short by \$389,390 (\$800,000 - \$410,610) for the 20% down payment.

Therefore, the Board Treasurer is proposing a *ONE-TIME* Special Assessment of \$265 per property which will provide for the purpose of meeting the down payment requirement with a small cushion (1,500 X \$265 = \$397,500).

The membership should understand that the new clubhouse will add an estimated additional \$380K to our annual operating budget, resulting in a dues increase of approximately \$250 per property until the mortgage is paid and a forever dues increase for the future cost of maintaining and operating a 10,000 sq. ft. building with an indoor pool

Anyone interested in proceeding with the new clubhouse building should vote YES on the proposed ONE-TIME Special Assessment of \$265, which will be billed upon approval of this ballot and due by August 1, 2025.

Without the funds for the 20% mortgage downpayment provided by this assessment, the clubhouse project CANNOT PROCEED as currently planned.

# Springtime Alert - Do Not Disturb Young Wildlife

Whether in their backyards or high on a mountain, it's almost certain Pennsylvanians will encounter young wildlife this time of year.

While some young animals might appear to be abandoned, usually they are not. It's likely their mothers are watching over them from somewhere nearby. So, when encountering young deer, birds, raccoons or other young wildlife, the best thing people can do is leave the animals alone.

"Most people want to do what they can to help wildlife, and when they see a young animal that appears to be abandoned, they want to intervene," said Wayne Laroche, the Game Commission wildlife management director. "What they don't realize is that, in all likelihood, they're doing more harm than good.

"Those young animals probably aren't abandoned at all, meaning that anyone stepping in to try to help not only is taking that youngster away from its mother, but also destroying its chances to grow up as it was intended," he said.

Adult animals often leave their young while they forage for food, but they don't go far, and they do return. Wildlife also often relies on a natural defensive tactic called the "hider strategy," where young animals will remain motionless and "hide" in surrounding cover while adults draw the attention of potential predators or other intruders away from their young. Deer employ this strategy, and fawns sometimes are assumed to be abandoned when, in fact, their mothers are nearby.

The Game Commission urges Pennsylvanians to resist the urge to interfere with young wildlife or remove any wild animal from its natural setting.

Such contact can be harmful to both people and wildlife. Wild animals can lose their natural fear of humans, making it difficult, even impossible, for them to ever again live normally in the wild. And anytime wildlife is handled, there's always a risk people could contract diseases or parasites such as fleas, ticks and lice.

Wildlife that becomes habituated to humans also can pose a public-safety risk. A few years ago, a yearling, six-point buck attacked and severely injured two people. The investigation into the incident revealed that a neighboring family had illegally taken the deer into their home and fed it as a fawn, and they continued to feed the deer right up until the time of the attack.

It is illegal to take or possess wildlife from the wild. Under state law, the penalty for such a violation is a fine of up to \$1,500 per animal. Under no circumstances will anyone who illegally takes wildlife into captivity be allowed to keep that animal, and under a working agreement with state health officials, any "high risk"

rabies vector species confiscated after human contact must be euthanized and tested; it cannot be returned to the wild because the risk of spreading disease is high.

Animals infected with rabies might not show obvious symptoms, but still might be able to transmit the disease. Though any mammal might carry rabies, the rabies vector species identified in the agreement are: skunks, raccoons, foxes, bats, coyotes and groundhogs.

People can get rabies from the saliva of a rabid animal if they are bitten or scratched, or if the saliva gets into the person's eyes, mouth or a fresh wound.

Only wildlife rehabilitators, who are licensed by the Game Commission, are permitted to care for injured or orphaned wildlife for the purposes of eventual release back into the wild. For those who find wildlife that truly is in need of assistance, a listing of licensed wildlife rehabilitators can be found on the Pennsylvania Association of Wildlife Rehabilitators website, <a href="https://www.pawr.com">www.pawr.com</a>.

If you are unable to identify a wildlife rehabilitator in your area, contact the Game Commission region office that serves the county in which the animal is found so that you can be referred to the appropriate licensed wildlife rehabilitator. Region office contact information can be found through the "Connect with Us" tab on the agency's website, <a href="www.pgc.pa.gov">www.pgc.pa.gov</a>.

# OFFICIAL NOTICE Letter of Credit / Dime Bank

Per the bylaws, we are required to notify the general membership in the next official publication if we borrow money, enter into contracts, issue notes or other evidences of debt, for money or labor done or money or property actually received, and to secure any of its obligations by mortgage, pledge security agreement or deed of trust of its property, franchises and income.

We obtained a Commercial Commitment for a Letter of Credit with The Dime Bank, for the purpose of the Land Development escrow, required by the Township for the purpose of Land Development of the Clubhouse property in the amount of \$304,081.85.

No loan was entered into with this Agreement. The cost of the Letter of Credit is \$4,000 for an 18-month term, plus a \$250 filing fee. At the completion of the clubhouse project, the letter of credit will be relinquished.




As per page 27 of the WALPOA Rules and Regulations, Schedule of Fines, speeding is a Tier 2 Offense with fines as much as \$350.

# **More Harm than Good**

While feeding deer may enhance wildlife viewing, decades of research has clearly shown that supplemental feeding leads to increased disease risk, long-term habitat destruction, increased vehicle collisions, habituation to humans and alteration of other deer behavioral patterns and, ultimately, the demise of the value of deer and deer-related recreation.

With CWD approaching our borders, the increased potential for disease transmission and outbreak is perhaps our greatest and most immediate concern, but habitat degradation, resulting in loss of



### **Spreading Feed Spreads Disease**

**ASSETS** 

Supplemental feeding congregates deer in unnatural densities. Gathering large numbers of deer into small areas creates a serious risk for spreading terminal dis-



eases such as chronic wasting disease and tuberculosis. Mange is another disease that spreads between animals in close contact. The spread of disease within and among species is encouraged by repeated and prolonged contact at feeding sites.

### **Eaten Out of House and Home**

Feeding can cause more deer to survive than the natural habitat can support, leading to long-term degradation of the habitat and diminishing the carrying capacity of the area. This is not new. A 1944 study reported, "feeding serves to concentrate deer in small areas year after year where animals do serious and possibly irreparable damage to native forage species, which in turn further reduces the carrying capacity of the range and makes deer increasingly dependent upon supplements."

Over years, the composition of the plant and animal communities can change markedly – diversity is reduced and less desirable plant species [found up to a mile from feeding locations] increase.

The forest understory declines and ground cover disappears, trees become larger and the number of dead trees increases. With less nesting cover available and nest predators such as raccoons and skunks being drawn to feeding sites, ground-nesting bird populations such as wild turkeys decline in feeding areas.
